- LOCATION:** L’Anse Creuse North High School
23700 21 Mile Road
Macomb Township, MI 48042
- TIME:** This meet will be run in one session. Warm-up will be from 8:00 to 8:45 AM, and the meet will start at 9:00 AM.
- RULES:** YMCA Standard Swimming Rules
- FACILITIES:** 25 yard, 8-lane pool with fixed starting blocks in deep end and Colorado 5 electronic timing system. Spectator seating capacity of 325, please refrain from bringing coolers, bags and coats into the stands. Locker rooms will be attended.
- ELIGIBILITY:** Limited to current members of YMCA swim clubs/teams, ages 9 and up. Age group is determined by swimmer’s age as of Dec. 1, 2008. Open to swimmers who have not achieved an individual YMCA State qualifying time. Swimmers who swim in relay events **ONLY** at State may still enter the “B” Cluster.
- ENTRY LIMITS:** Swimmers may enter a maximum of 3 individual events and 2 relays. These are the Michigan Cluster Eastern Division Championship rules for entry.
- ENTRY DEADLINE:** Entries **MUST** be received no later than **11:59 PM on February 25.**
- ENTRIES:** Fees are \$4.00 per individual event and \$16.00 for relays. **NO** phone entries will be accepted! **NO** post-dated checks. Entry forms, import files for Team Manager can be downloaded from the MYM website: www.macombmarlins.com. All entries must include correct swimmer name, gender, age, team, event, and seed time.
- Teams are encouraged to submit their entries in Hy-Tek format to entries@macombmarlins.com. If submitting your entries using hardcopy forms, then all hardcopy entry forms are required to be filled out completely and legibly. Please use the entry forms provided. For Hy-Tek entries, it is only necessary to send the entry summary form.

- AWARDS:** For age groups 9-10 and 11-12
Individual: Medals 1-6, Ribbons 7-12, Relays: Medals 1-6, Ribbons 7-12
For age group 13-18
Individual: Medals 1-6, Ribbons 7-12, Relays: Medals 1-3, Ribbons 4-6
- SEEDING:** Slowest to fastest. Swimmers entering with no time will be seeded in the slowest heat and will be eligible for awards.
- MARSHALLING:** Marshalling using a ready area on pool deck.
- TIME TRIALS:** 50-100-200 yard time trial events will be available at the conclusion of the meet. The cost of each time trial is \$5.00. Entries for time trials will be taken until 12:15 PM. Time trials are open to any YMCA swimmer attempting to qualify for Zones or Nationals, or any YMCA swimmer attempting to obtain a personal best time.
- ADMISSION:** \$3.00 for non-swimmers over 12, \$3.00 for meet program
- CONCESSIONS:** Concession stand with a large menu of healthy snack items and a full lunch menu will be available.
- MEET DIRECTOR:** David Pitlock, 586-412-0987, dpitlock@yahoo.com
- COACH'S ROOM:** Coaches lounge will be setup near the pool deck. Food and drink will be provided.
- LOST & FOUND:** Lost articles may be claimed and picked up in awards room. Articles that are not claimed during the meet will be held for two weeks. For lost articles, please contact Brigid Hranchook at lost@macombmarlins.com.
- VOLUNTEERS:** Any person wishing to time or be an official should report to the head timer or referee 30 minutes before the start of the meet. Watches will be supplied.
